## Introduction

□ PIC established in February 2011 as an independent organisation.

□ Core funding agreement signed with the Swedish International Development Agency (Sida) November 2011.

□ PIC originates from the Cambodia-Canada Legislative Support Project, but is a permanent independent body, adopting an institutional approach to parliamentary development instead of a project approach.

PIC takes requests for research and activities directly from parliamentary commissions and MPs and Senators from all parties.

# Mandate and Core Values of PIC

#### Mandate

□ To assist the Cambodian legislature in building its capacity as an effective democratic institution through the provision of nonpartisan expertise and training to Parliamentarians and Secretariat Staff

□ To facilitate experience-sharing with others parliaments in the Sub-Mekong region as well as with IPU members

Credibility, Accountability, Participation, Openness, Integrity, Non-discrimination and Transparency.

# **Objectives of PIC**

Approach/Working Methodology

□ **Needs-oriented approach,** responding to the direct requests of Commissions and Parliamentarians from all parties whose competencies relate to PIC's working fields.

□ **PIC does not follow its own agenda**, it assists with issues contained in commission's workplan and/or on the legislative agenda.

□ PIC in a **support and advisory role.** MPs/CPs take the lead in all aspects of planning and organising outreach and representation activities, PIC offers technical and organisational assistance, and attempts to source funding for activities.

□ **Training for Secretariat Staff.** PIC takes requests for training from Secretariat Staff on behalf of MPs/CPs. Secretariat Staff receive on-the-job training/mentoring from PIC specialists, returning to the Secretariats to pass on the knowledge and skills they acquired during their time with PIC.
